



## Siparex Intermezzo supports the growth of broker OTCex

**Siparex Intermezzo is investing in OTCex, the leading financial holding company in a financial services group specialising in intermediation and asset management, to support its strong growth.**

Founded by Frédéric Metz and Richard Hadjimegrian, the OTCex/HPC group brings together highly complementary financial expertise covering all asset classes (equities, interest/credit rates, commodities) and provides a global intermediation offer with offices in Paris, London, New York, Hong Kong and Geneva. The Group has around 230 employees serving a very diversified client base (banks, insurance companies, mutual insurance companies, asset managers, corporate, etc.).

Over the past 5 years, an asset management activity has also been developed. OTCex is therefore the reference shareholder of Sanso Investment Solutions (700 M€ in assets under management at 31/12/2017), a particularly promising structure leading to a differentiating strategy in the field of ESG thematic management.

Under the leadership of its founders and Olivier Stephanopoli, in recent years the OTCex/HPC Group has experienced strong growth driven by the development of new brokerage offers and international development. Thus, in 2017, the Group's consolidated turnover amounted to 115 M€, up 14% compared to 2016.

Advised by the teams of EY CF Financial Services, the leaders of OTCex have chosen Siparex Intermezzo to reinforce the Group's regulatory quasi-equity with an issue of 7.5 M€ to support its strong growth in the context of increased prudential requirements.

Comment from Olivier Stephanopoli, OTCex: *"We are delighted with the conclusion of this issue of quasi-equity, which will structure the Group's regulatory financing on a long-term basis. This financial partnership with Siparex Intermezzo also allows us to strengthen our corporate governance, especially around issues and reflections on our digital and electronic strategy."*

Comment from Richard Dalaud, Siparex Intermezzo: *"We are delighted with the structuring of this transaction, a first in France in terms of regulatory capital enhancement by a private equity and mezzanine player. Impressed by the recognised know-how of OTCex, one of the European leaders in its markets, we will focus on supporting the digital transformation of the company on its core businesses."*
